In short, we not only managed the situation without any crisis or conflict with the road user but we are also participating in the current revolution to be digital and cashless. Let the year 2017 make more inroads to joy and prosperity for our roadies.

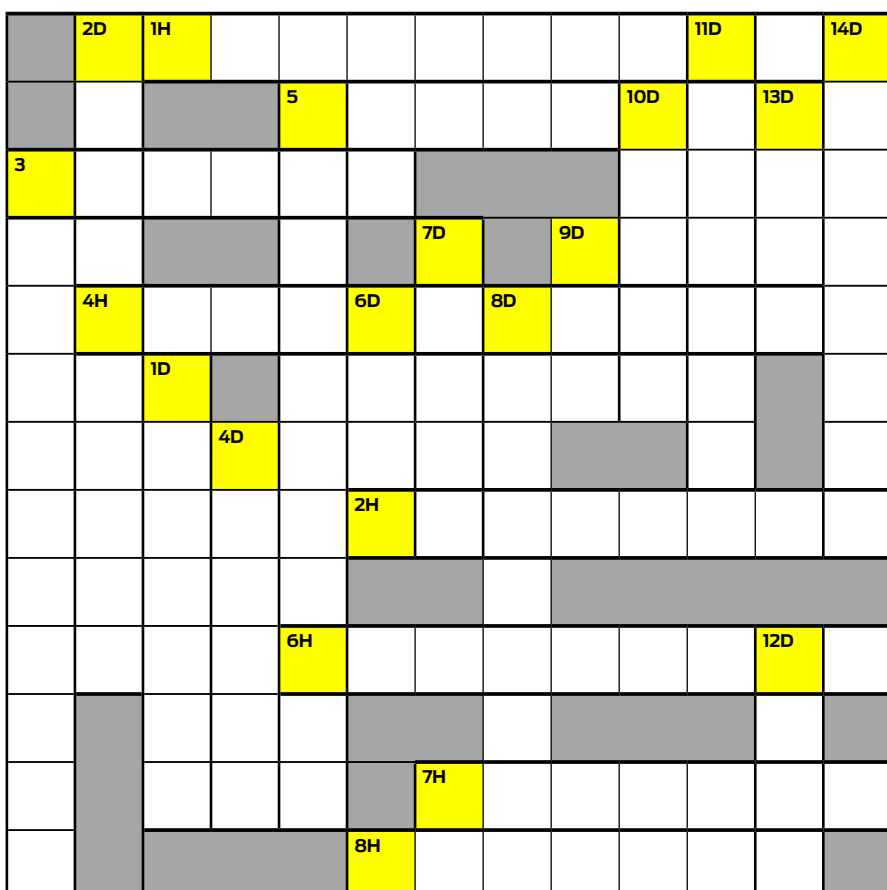
OTHER HIGHLIGHTS OF 2016
